The share classes of Triodos SICAV II - Triodos Microfinance Fund listed in Appendix 1 are reporting funds for the reporting period ended 31 December 2019.

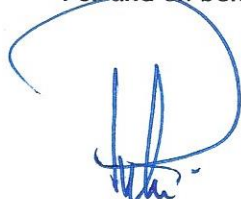
All share classes listed in Appendix 1 remain Reporting Funds at the date of this letter.
