# Interest Rates

---

Triodos Bank interest rates are 'gross rates' and 'Annual Equivalent Rates' (AER). The gross rate is the rate payable without any tax taken off. Credit interest on all our accounts is paid gross. AER shows what the interest rate would be if interest was paid and compounded once each year.

We may change the interest rates on your Account with us. Please see our Terms and Conditions for businesses and charities for more information.

Fixed Term Deposit interest is calculated daily, up to and including the day before the Fixed Term Deposit matures, and is paid annually and on maturity.

The Triodos Business and Charity Deposit Account and Triodos Treasurers Reserve interest is paid or credited quarterly on 1 January, 1 April, 1 July and 1 October. Charity Current Account interest is paid or credited on the first day of each month.
