This form should be completed either by printing a blank copy and filling in the required fields, or by filling in the fields online and then printing the form. The declaration at the end of this form must be signed and dated by both the account holder to be removed and the remaining account holder, and then this form should be returned to us at our Freepost address. Our Freepost address is Royal Mail registered and simple to use. Write it exactly as shown below on your envelope and your letter will get to us free of charge (no stamp required):
