Accounts cannot be opened directly. • To open an account the account holders must be UK residents. • The account can be in sole or joint names. • Once the account is open funds can be paid in from any account. • There is no maximum balance. • The account can be managed online or by post.
Can I withdraw my money?	<ul style="list-style-type: none"> • Yes, this is an easy access account, no notice for withdrawals is required and withdrawals can be made at any time. • There is no limit on withdrawals. • Withdrawals can be made online to a nominated account or by post. • Closure is allowed at any time.
